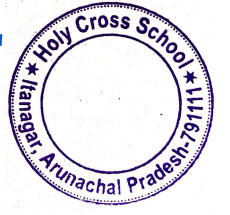

Subject: Declaration of holiday due to rising cases of Conjunctivitis

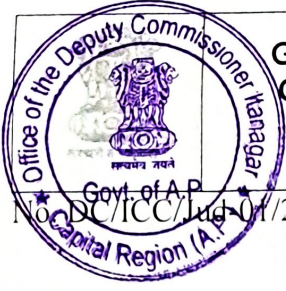
Dear Parents/ Guardians.
